# BUDGET DRIVING SCHOOL OF IMPERIAL COUNTY TERMS OF SERVICE

Last updated on 05/12/23.

#### 1. Preamble.

- 1.1. THIS IS A LEGAL AGREEMENT BETWEEN YOU AND BUDGET DRIVING SCHOOL OF IMPERIAL COUNTY ("Budget Driving School"). AS USED HEREIN, "YOU" MEANS A USER OF THE SERVICE. YOU SHOULD CAREFULLY READ THIS AGREEMENT.
- 1.2. Budget Driving School owns and/or operates the following websites:

- 1.3. These websites and the services available thereon and other services Budget Driving School may make available from time to time (together with associated and successor websites and services) are referred to as the "Service".
- 1.4. THIS AGREEMENT GOVERNS YOUR USE (AND THAT OF ANY PERSON YOU PROVIDE ACCESS TO USE) OF THE SERVICE. BY USING OR ACCESSING THE SERVICE, OR BY PROVIDING ACCESS TO ANOTHER PERSON TO USE THE SERVICE, YOU AGREE TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO BE BOUND BY THIS AGREEMENT, YOU ARE NOT PERMITTED TO USE THE SERVICE OR TO PROVIDE ANOTHER PERSON WITH ACCESS TO USE THE SERVICE.

#### 2. No refunds or transfers.

- 2.1. By agreeing to these terms, the parties involved acknowledge and understand that all sales are final and non-refundable. Once a purchase is made, no refunds, returns, or exchanges will be provided unless explicitly stated otherwise in this agreement or required by applicable law.
- 2.2. Additionally, all goods and services under this agreement are non-transferable. The parties agree that any products, services, or rights acquired under this agreement cannot be transferred, assigned, or sold to any other student without the express written consent by Budget Driving School.
- 2.3. This clause is a fundamental part of the agreement and applies to all transactions, purchases, and engagements between the parties involved.

#### 3. Goods and Services Timeframe.

3.1. By accepting these terms, the parties hereby agree that all goods and services purchased under this agreement must be utilized within one year from the date of purchase. Failure to utilize the purchased goods and services within this stipulated timeframe shall result in the forfeiture of any and all rights associated with the purchase.

- 3.2. The parties acknowledge and understand that Budget Driving School shall not be held responsible for any inability or failure to use the purchased goods and services within the specified timeframe. No refunds, exchanges, or extensions will be provided for goods and services that remain unused beyond the one-year period.
- 3.3. This clause is an integral part of this agreement and applies to all transactions and purchases made between the parties.

## 4. Changes to this Agreement.

4.1. Budget Driving School reserves the right, at its sole discretion, to change, modify, add to, supplement or delete any of the terms and conditions of this Agreement at any time, effective with or without prior notice; provided, however, that Budget Driving School will provide a user with notification of any material changes by email, postal mail, website posting, pop-up screen, or in-service notice. If any future changes to this Agreement are unacceptable to you or cause you to no longer be in compliance with this Agreement, you must immediately stop using the Service. Continued use of the Service following any revision to this Agreement constitutes your acceptance of any and all such changes.

#### 5. Access to the Service.

- 5.1. Subject to your acceptance of and compliance with this Agreement, Budget Driving School grants to you a non-exclusive, non-transferable, revocable limited license to use the Service for your personal non-commercial, private use. # 17. Governing Law/Waiver of Injunctive Relief.

- 17.1. This Agreement and all aspects of the Service will be governed by and construed in accordance with the internal laws of the United States and the State of California governing contracts entered into and to be fully performed in the State of California (i.e., without regard to conflict of laws provisions) regardless of your location. With respect to any disputes or claims not subject to informal dispute resolution or arbitration (as set forth below), you agree not to commence or prosecute any action in connection therewith other than in the state or federal courts located in the State of California, and you hereby consent to, and waive all defenses of lack of personal jurisdiction and forum non conveniens with respect to, venue and jurisdiction in the state and federal courts located in the State of California.
- 17.2. To expedite resolution and control the cost of any dispute, controversy or claim related to this Agreement ("Dispute"), you and Budget Driving School agree to first attempt to negotiate any Dispute (except those Disputes expressly provided below) informally for at least thirty (30) days before initiating any arbitration or court proceeding. Such informal negotiations commence upon written notice from one person to the other. You will mail your notice to Budget Driving School of Imperial County at the following address:

- 17.3. If you and Budget Driving School are unable to resolve a Dispute through informal negotiations within 30 days, either you or Budget Driving School may elect to have the Dispute (except those Disputes expressly excluded below) finally and exclusively resolved by binding arbitration. Any election to arbitrate by one party will be final and binding on the other. YOU UNDERSTAND THAT ABSENT THIS PROVISION, YOU WOULD HAVE THE RIGHT TO SUE IN COURT AND HAVE A JURY TRIAL. The arbitration will be commenced and conducted under the Streamlined Arbitration Rules and Procedures (the "Rules") of JAMS, which is available at the JAMS website www.jamsadr.com. The determination of whether a Dispute is subject to arbitration will be governed by the Federal Arbitration Act and determined by a court rather than an arbitrator. Your arbitration fees and your share of arbitrator compensation will be governed by the Rules. The arbitration may be conducted in person, through the submission of documents, by phone or online. The arbitrator will make a decision in writing, but need not provide a statement of reasons unless requested by a party. The arbitrator must follow applicable law, and any award may be challenged if the arbitrator fails to do so. Except as otherwise provided in this Agreement, you and Budget Driving School may litigate in court to compel arbitration, stay proceedings pending arbitration, or to confirm, modify, vacate or enter judgment on the award entered by the arbitrator.
- 17.4. You and Budget Driving School agree that any arbitration will be limited to the Dispute between Budget Driving School and you individually. To the full extent permitted by law, (a) no arbitration will be joined with any other; (b) there is no right or authority for any Dispute to be arbitrated on a class- action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

17.5. You and Budget Driving School agree that the following Disputes are not subject to the above provisions concerning informal negotiations and binding arbitration: (a) any Disputes seeking to enforce or protect, or concerning the validity of, any of your or Budget Driving School's intellectual property rights; (b) any Dispute related to, or arising from, allegations of theft, piracy, invasion of privacy or unauthorized use; and (c) any claim for injunctive relief.

# 18. Waiver/Severability.

- 18.1. The failure of Budget Driving School to require or enforce strict performance by you of any provision of this Agreement or to exercise any right under them will not be construed as a waiver or relinquishment of Budget Driving School's right to assert or rely upon any such provision or right in that or any other instance.
- 18.2. You and Budget Driving School agree that if any portion of this Agreement, except any portion of Section 15.5, is found illegal or unenforceable, in whole or in part by any court of competent jurisdiction, such provision will, as to such jurisdiction, be ineffective to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of this Agreement, which will continue to be in full force and effect. If Section 15.5 is found to be illegal or unenforceable then neither you nor Budget Driving School will elect to arbitrate any Dispute falling within that portion of Section 15.5 found to be illegal or unenforceable and such Dispute will be decided by a court of competent jurisdiction in the State of California, and you and Budget Driving School agree to submit to the personal jurisdiction of that court.

#### 19. Miscellaneous.

- 19.1. Budget Driving School operates and controls the Service from its offices in North America.

The section headings used in this Agreement are for convenience only and will not be given any legal import. Upon Budget Driving School's request, you will furnish Budget Driving School any documentation, substantiation or releases necessary to verify your compliance with this Agreement. You agree that this Agreement will not be construed against Budget Driving School by virtue of having drafted it.
- 19.4. You hereby waive any and all defenses you may have based on the electronic form of this Agreement and the lack of signing by the parties hereto to execute this Agreement.

#### 20. Statute of Limitations.

20.1. You and Budget Driving School both agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to use of the Service or this Agreement (including the Privacy Policy) must be filed within ONE (1) YEAR after such claim or cause of action arose or will be forever barred.

## 21. Online Scheduling Agreement.

21.1. You acknowledge and agree that the Budget Driving School Online Scheduling Agreement is incorporated and made part of this Agreement. # 22. Force Majeure.

22.1. Any delay or failure in the performance by Budget Driving School hereunder shall be excused if and to the extent caused by the occurrence of a Force Majeure. For purposes of this Agreement, Force Majeure shall mean a cause or event that is not reasonably foreseeable or otherwise caused by or under the control of the party claiming Force Majeure, including acts of God, fires, floods, explosions, riots, wars (whether or not war is officially declared), hurricane, sabotage, terrorism, vandalism, accident, restraint of government, governmental acts, injunctions, labor strikes that prevent Budget Driving School from furnishing the materials, services, and/or equipment, and other like events that are beyond the reasonable anticipation and control of the party affected thereby, despite such party's reasonable efforts to prevent, avoid, delay, or mitigate the effect of such acts, events or occurrences, and which events or the effects thereof are not attributable to Budget Driving School's failure to perform its obligation(s) under this Agreement.
